

3rd AWARD TO GOOD PRACTICES IN BILINGUAL EDUCATION

CÓRDOBA, OCTOBER 2021

RULES AND REGULATIONS

1. Purpose

The 7th International Conference on Bilingual Education, organised by the University of Cordoba and which will take place from 26th to 29th October 2021, announces the 3rd Award to Good Practices in Bilingual Education (hereinafter, the Prize), with the aim of promoting and disseminating good practices, educational innovation projects and the involvement of educational centres in relation to bilingual education.

2. Participants

Participation is open to schools at all levels, from Pre-school to Higher Education, whether public, state-subsidised or private.

3. Registration and submission of applications

In order to participate, those interested must register for the Award through the website of the 7th International Conference on Bilingual Education, in the section dedicated to it and by filling in the form that can be found on the website. It is compulsory for the registration to be made by a tutor, teacher or teacher from the school. In any case, this person must provide his/her personal details and the details of the educational centre where the teaching initiatives in the field of bilingual education are carried out.

More than one candidature may be submitted per school.

In order to award the prizes, after their evaluation by the Jury selected for this purpose by the Organising Committee of the 7th International Conference on Bilingual Education, the person responsible for the candidacy will be notified by e-mail in order to be able to award the prizes.

Participation is free of charge, in such a way that it will not be necessary to pay any amount in order to obtain the prizes in the competition.

The essential details to be able to participate are:

- ◆ Person responsible for the project
- ◆ E-mail address of the person responsible for the project
- ◆ Name of the school
- ◆ Full postal address of the school
- ◆ Province / Region / Country
- ◆ Contact telephone number

This information will be required on the award website in order to be able to register the candidatures.

4. Evaluation and awarding of prizes

The projects will be evaluated according to the following criteria:

- ◆ Objectives and degree of educational innovation.
- ◆ Originality of the proposal.
- ◆ Clarity of the descriptive report of the project.
- ◆ Degree of involvement of teachers, students and interrelation between schools, as well as the degree of educational inclusion at all levels.
- ◆ Application of the CLIL approach in the classroom.
- ◆ Multidisciplinarity, valuing the integration of several subjects with different contents.

For the drafting of the project, the following sections must be completed in the form created for this purpose:

- ◆ Title of the project
- ◆ Participants
- ◆ Introduction and justification
- ◆ Objectives
- ◆ Methodology and activities carried out
- ◆ Results.
- ◆ Assessment of good practices

5. Award

The 7th International Conference on Bilingual Education will award a prize for the best experience of good practices in bilingual education, in accordance with the parameters indicated in section 4. The first prize will consist of a trophy and a diploma.

Second and third prizes will also be awarded in the form of diplomas, in accordance with the parameters indicated in section 4.

6. Deadline

The deadline for the presentation of candidatures will be from 01st June to 05th October 2021, both included, with their presentation being accepted exclusively during this period of time from the section of the Congress website set up for this purpose.

7. Jury

The jury will be freely appointed by the Organising Committee of the 7th International Conference on Bilingual Education. The jury's decision will be final.

8. Communication and awarding of prizes

The winning candidates will be officially announced on the website of the 7th International Conference on Bilingual Education on 15th October 2021 and the award ceremony will take place on 29th October 2021.

9. Intellectual property rights

All rights of exploitation of the intellectual property that may apply to the candidatures presented (reproduction, public communication, distribution and transformation) will be assigned to the Organising Committee of the 7th International Conference on Bilingual Education, without any territorial or temporal limit, the latter acquiring the right to publish them, by any system or format, modality or procedure, always mentioning the authorship, the teachers responsible and the educational centre. The person responsible for the project submitting an entry declares and guarantees that the entry does not infringe any copyright.

The winning proposals of the Award authorise the Organising Committee of the 7th International Conference on Bilingual Education, without territorial or time limit, to publish, reproduce, disseminate and use by all written, spoken and filmed media in any form by any means and on any support, the good teaching practices, in order to give them visibility and dissemination, provided that the purposes are informative in relation to the law in force, for which by accepting the present rules the necessary authorisations are issued.

10. Data protection

The Organising Committee of 7th International Conference on Bilingual Education (University of Cordoba) is the owner of the websites <https://conference.bilingualeducation.es>, <http://virtual.bilingualeducation.es/virtual/> and <https://abstracts.bilingualeducation.es/index.php>, and is responsible for the files generated with the personal data provided by users through this website.

The applicant will be responsible for this declaration and for the access and correct use of the website and authorises the Organising Committee of the 7th International Conference on Bilingual Education to process the personal data that he/she voluntarily provides for the following purposes:

- ◆ To manage the participation in the 3rd Award to Good Practices in Bilingual Education.
- ◆ To respond to queries received.
- ◆ To send personal or official congratulations.
- ◆ The dissemination in web publications, social networks, written media, videos, television, of the activity of the 7th International Conference on Bilingual Education (University of Cordoba).

Data will be treated with confidentiality and will not be accessible to third parties for purposes other than those for which they have been authorised.

The participant will be responsible, in any case, for the veracity of the data provided, and the Organising Committee of the 7th International Conference on Bilingual Education reserves the right to exclude from the registered services any user who has provided false data, without prejudice to other actions that may be applicable by law.

11. Acceptance of the rules

Potential participants are informed that the mere participation in the 3rd Award to Good Practice in Bilingual Education implies acceptance of these rules, as well as the decisions of the organisers.
